THE WEIGHTINGS OF SCHOOL-BASED ASSESSMENT AND END-OF-YEAR EXAMINATION FOR GRADES R-11 FOR THE ACADEMIC YEAR 2022

1. The purpose of this Assessment Instruction is to inform stakeholders about the weightings of School-Based Assessment and end-of-year examination for Grades R-11 for the academic year 2022.
2. In terms of policy, the National Protocol for Assessment Grades R– 12 stipulates that the School-Based Assessment marks allocated to assessment tasks completed during the school year will be as per the CAPS Documents.
3. During the 2020 academic year, the DBE issued Circular S7 which released the revised promotion requirements for different Grades as an interim measure for the academic year 2020-22.



4. Following are the weighting of School Based Assessment and end of the Examination in 2020-2022 academic years.

PHASE	CAPS REQUIREMENTS	COVID-19 AMENDMENTS FOR 2020-2022
Foundation Grades R-3	100% SBA	100% SBA
Intermediate Phase Grades 4-6	60% SBA- 40% Exam	80% SBA- 20% Exam
Senior Phase Grades 7-9	40% SBA- 60% Exam	80% SBA- 20% Exam
Grades 10 -11	25% SBA- 75% Exam	60% SBA- 40% Exam

5. In the case of subjects with a practical component, allocate 20% of the examination component to the PAT.
6. In the case of Languages, 12,5 % of the examination component (First Additional Language and Home Language) and 25% (Second Additional Language) should be allocated to Orals.
7. You are kindly requested to bring the content of this Circular to the attention of all provincial and district officials, principals and teachers of both public and independent schools, and relevant stakeholders
