The Mathematics P1 Grade 12 for June Examinations 2023 was written on Friday, the 02 June 2023. We were made aware of errors and omissions that was discovered during the marking process.

The amendment with regards to the marking was prepared in conjunction with the examiner and the moderator of the paper. This amendment addresses the errors and omissions and also ensures that learners are not disadvantaged. The following standardised approach to marking must be adopted across the Province.

**ERRATA: JUNE 2023 MATHEMATICS P1 (MARKING GUIDELINE)**

There was an error/omission in the **AFRIKAANS VERSION** of the question paper. Therefore, the errata only applies to **Afrikaans** candidates.

**In question paper:**

10.2.2 Wat is die waarskynlikheid dat 'n kind nie op enige gegewe dag sal val nie? (2)






**It was supposed to be:**
