In order to address this and to ensure that learners are not disadvantaged, the following standardised approach to marking must be adopted across the Province. The following guidelines regarding marking was prepared in conjunction with the examiner and moderator.

QUESTION 1

1.1.1 Should be D and not C

1.1.13 **Poor quality of picture:**

Accept both C and D.

1.1.19 Not in ATP, award mark to learners

1.3.1 **Add:** Glycaemia as another option

1.3.3 **Add:** Profit-margin as another option

1.3.6 Cash flow projection according to the ATP is optional.
Award learners with one mark.

QUESTION 4

4.6 **Additional option:**

As seasons change and a new season starts, fashion cycles may overlap, as one fashion moves towards its peak, the other fashion is outdated.

QUESTION 6

6.3.1 **Add:** (Two) workers

6.4 **Replace with:**

$$4 \times R80,00 \checkmark^1 = R320,00$$

$$R320,00 + R 20,00 + R300,00 = R640,00 \checkmark^2$$

$$R640,00 \times 40\% \checkmark^3 = R256,00 \checkmark^4 \text{ or } R600 \times \frac{40}{100} \checkmark^5 = R256,00 \checkmark^6$$

$$\text{Total cost} = R640,00 + 256,00 = R896,00 \checkmark^7$$

OR

$$R640,00 \times \frac{140}{100} \checkmark\checkmark = R896,00 \checkmark^{10}$$
