ISIXHOSA FAL PAPER 1

The paper was written on the 04th September 2024. From our MG discussion which was held on the 05th/ 09/ 24, we have found out that the following questions do not have answers from their texts and must be referred as unfair questions to the candidates.

This amendment with regards to the marking was prepared in conjunction with Examiner and Moderator. This amendment addresses the errors and also ensures that Learners are not disadvantaged and so the following standardised approach must be adopted across the province.
